### **General Terms and Conditions:**

- 1. The rates quoted shall include all applicable taxes.
- 2. Regular servicing & inspection of the elevators/Lifts should be carried out at least once in a month by the service provider and service report to be countersigned from the Assistant Engineer "Electrical" and submitted to the office.
- 3. The service provider shall regularly examine elevator equipments and provide Gear oil, Lubricant, Grease, Break Shoe Gibbs, Push Buttons of Car and Landings etc. required for proper maintenance of the lifts.

- 4. The service provider shall also attend any breakdown call immediately.
- 5. A log book is to be maintained by the agency for every visit to ILS for repair / maintenance and shall be counter signed by Assistant Engineer "Electrical", ILS.
- 6. An agreement detailing the terms & conditions shall be executed with the service provider for entering into an AMC.
- 7. The service provider shall furnish full experience details indicating the parties with whom similar assignments (Comprehensive AMC for Lifts) were undertaken.
- 8. In case of failure to provide service at any time the agency will be liable to pay a penalty @10% of the yearly agreed contract amount.
- 9. Mode of payment: Quarterly by cheque, no advance payment shall be made towards Comprehensive AMC.
- 10. Income tax & other statutory taxes if applicable shall be recovered from billing amount.
