The quotation for the AMC of DG set 1010 KVA-415V, 320 KVA - 415 V & Diesel Fire Pump should be submitted in proper format as per ANNEXURE-I & ANNEXURE-II (enclosed).

General Terms and Conditions:

- 1. The agency should be in possession of valid Licence / Registration / Authorization for Diesel Generator / Fire pump maintenance works up to rated capacity of 320 KVA to 1010 KVA from original engine manufacturer (OEM) or its equivalent organizations etc...
- 2. The rates quoted shall include all applicable taxes.
- 3. Regular servicing & inspection of the DG sets should be carried out at least once in a month by the service provider, preferably during 1st week of the every month.
- 4. The service provider shall perform preventive maintenance to the equipments mentioned above and its accessories as per service manual provided by the OEM.
- 5. The service provider shall also attend any breakdown call immediately.
- 6. A log book is to be maintained by the agency for the service provided which is to be countersigned by the officer / engineer in charge.
- 7. An agreement detailing the terms & conditions shall be executed with the service provider for entering into an AMC.
- 8. The service provider shall furnish full experience details indicating the parties with whom similar assignments (AMC) were undertaken.
- 9. In case of failure in providing services, agency will be liable to pay a penalty for that period / Month on the basis of the monthly agreed amount , which will be deducted from the amount payable by ILS to them from the bill.
- 10. Mode of payment: The amount agreed will be paid on quarterly basis after successful completion of services for the month / quarter. Income Tax, Sales Tax etc. shall be deducted from the payment to be made as per the existing law.

Agency has to submit the service report along with the bill duly signed by the competent

authority.

That in case of any violations of the terms & conditions of the contract by the agency, the agreement may be terminated by issue of notice in writing one month in advance. In case of payment related disputes, the same may be settled by both the parties / Director.

That regarding the interpretation of any clause in this agreement, the decision of the

Director, ILS shall be final and binding on the agency.

The AMC will be for a period of 1 year, which is extendable for further period if required depending on satisfactory fulfillment of all 'Terms & Conditions' of agreement. However, the AMC may be terminated at any time before the expiry of contract, depending on the requirement/performance of the service provider.

The tender must be accompanied by bid security / earnest money @5% of its total quoted AMC amount in the form of Demand Draft from any nationalized bank of India & in favour of the Director, Institute of Life Sciences. The bid security / Earnest money of successful bidder shall be retained and for others, the bid security / earnest money will be returned within 30 days of completion of bid evaluation. No interest is payable on this deposit.

The successful bidder shall furnish @ 5% of its agreed amount as 'Performance Guarantee' in addition to bid security / earnest money in favour of "Director, Institute of Life Sciences" in the form of Demand draft from any nationalized bank which shall remain valid throughout the period of contract. No interest is payable on this deposit. If the approved party fails to execute the agreement deed from the specified date, the earnest money will be forfeited. The interested bidders/Service providers may visit this office during working hours to inspect the DG sets & related equipments or for any further clarification.

The Authority of Institute of Life Sciences or any other person(s) authorized by him/her on his/her behalf reserves the right to accept any, in full or in part, or reject any or all the tenders without assigning any reasons thereof and no correspondence in this respect will be entertained.
