NOTICE INVITING QUOTATIONS

Sealed quotations are invited from **established & registered vendors for** bidding suitable price in respect of supplying spares for firefighting, alarm & detection system mentioned in Annexure. The sealed quotations may be submitted to the Director Institute of Life Sciences (ILS), Bhubaneswar on or before **19.03.2018** up to 03.00 PM and the quotations will be opened on the same day at 3.30 PM in presence of intending vendors.

Terms & Conditions

(a)Bidders may visit ILS for inspection of site equipments from **26.02.2018** to **19.03.2018** between 3.00 to 5.00 PM, if required and satisfy themselves of the items they are bidding for. No disputes regarding the dimensions, nature or quality of spares shall be entertained if found unsuitable as per ILS requirement.

(b) The quotation submitted after the due date and time shall be rejected. Quotation must be clear & legible, duly signed by authorized signatories. Any addition / alteration/ overwriting / correction etc. must be signed by vendor / his authorized signatory.

(c) Items will be procured from lowest bidder if they fulfill all criteria's mentioned in the NIT.

(d) The successful bidder has to supply spares at Institute of Life Sciences, Bhubaneswar within four weeks after receiving of order.

(e) In case, successful bidder fails to supply the items within the stipulated time period, their bid / order will be cancelled automatically. No further query will be entertained.

(f) The labour, transport and other arrangements will have to be made by the bidder at their risk, cost and responsibility.

(g) Each page of the quotation will be signed and stamped by the authorized signatories and incomplete and unsigned quotations are liable to be rejected.

(h) The rate quoted shall be final excluding applicable taxes only.

- (i) Payment will be made through NEFT/ RTGS only after successfully supplying of spares. The vendor is to provide a copy of the registration certificate / GST / PAN Card & bank detail, whichever is applicable.
- (j) Income tax, sales tax, etc. shall be deducted from the payment to be made to the vendor as per the existing law.
- (k) Notwithstanding the above or otherwise, Director ILS shall reserve exclusive discretion to accept or reject any bid offer without assigning any reasons.
