### INSTRUCTIONS TO BIDDERS

- 1. Envelop -1 -(EMD) This envelops shall contain the EMD, the amount and the manner in which to be deposited as started in the tender notice and sealed.
- 2. Envolpe-2 ---- Technical Bid:

This envelop shall contain the **technical bid** documents duly signed by the bidder in all pages shall

- List of similar works completed last 3 years, duly supported by completion certificate i. issued by the competent authority. Similar works mean one no. of renovation work involving aluminum partition, water supply, false ceiling and repair work etc. amounting to Rs 1.50 lacks. ii.
- The completed tender paper along with valid registration certificate, valid GST registration certificate, PAN card & work completion certificate.

## 3. Envelop-3----- PRICE BID

Price bids of only qualified bidders shall be opened on the date and time fixed for opening of Price-Bid and intimated to the bidders who meet the pre-qualifying criteria. .The tenderer whose Technical bid has not been found acceptable will be advised about this fact and asked to take back the earnest money and the unopened Financial bid.

## The price bid should contain the following:-

- i) Price bid shall contain the item rates duly filled in words and figures in Bill of Quantities (BOQ) indicating total of all items and grant total.
- ii) After filling the rates as stated above all pages shall be signed by the contractor. Corrections shall be avoided. However if there are certain corrections, all corrections must be duly signed by the bidder in original and duly stamped.
- iii) There after the price bid documents shall be sealed by the contractor.
- iv) Rebate, if offered, shall be shown separately below the total of BOQ items. No conditional rebate will be acceptable. Failure to follow this procedure will render the bid liable for rejection.

Bids must be received in sealed envelope & must be either delivered by hand or posted at the following address so as to reach not later than the last date/time specified in the NIT to **DIRECTOR** INSTITUTE OF LIFE SCIENCES, CHANDRASEKHARPUR, and BHUBANESWAR-23. The name and mailing address of the Applicant (bidder) shall be clearly marked on the envelopes. Bids received late i.e. after the due date and timing for receipt of bids shall not be accepted/considered for evaluation and such bids shall be returned unopened.

### 4.0 EARNEST MONEY DEPOSIT (EMD)

- 4.1 The Bidders are required to deposit the EMD in favour of ILS for Rs .4487 /- work in following forms only.
- a. Crossed Demand Draft of any Indian Scheduled Bank only, in favour of INSTITUTE OF LIFE SCIENCES and payable at BHUBANESWAR drawn on any Indian Scheduled Bank in a separate envelope super- scribing "EMD"
- 4.2 EMD in any other form shall not be accepted.
- 4.3 ILS shall summarily reject any bid not accompanied by the EMD as mentioned above.
- 4.4 After evaluation of financial bids, the EMD of unsuccessful bidders will be returned Within a month from the end of the tender validity period.
- 4.5 The EMD of the successful bidder will be retained as part of the security deposit..
- 4.6 The EMD of the bidder, whose Technical bid is found not acceptable, will be returned as soon as scrutiny of Technical bid has been completed.
- 4.7 No interest shall be paid on the EMD.

#### 5.0 VALIDITY OF BID

- **5.1** Bids shall remain valid and open for acceptance for a period of **three month** from the date of opening of Technical Bid/ Price bid. Should the bidder fail to keep the bid open for acceptance as stated above or if the bidder withdraws his bid before the expiry of the said period or makes any modification in terms and conditions of the bid which are not acceptable then ILS without prejudice to any other right or remedy shall be at liberty to forfeit his 50% EMD absolutely.
- 5.2 In exceptional circumstances, prior to expiry of the original validity period, ILS may request the bidders for an extension in the period of validity by no of days as may be required. The request and the responses thereto shall be made in writing or by cable or fax. A bidder may refuse the request without forfeiting his EMD. A bidder agreeing to the request will neither be required nor be permitted to modify his bid but will be required to extend the validity of his EMD correspondingly.

#### 6.0 SUBMISSION AND OPENING OF BIDS.

- 6.3 No bid shall be accepted unless it is properly sealed.
- 6.4 Bid Box for the work shall be sealed at the time fixed in NIT on the date of receipt and no bid shall be accepted afterwards. The bids that have not been submitted up to or before the stipulated time and date of receipt shall not be considered and therefore deemed to be rejected. Such bids shall be returned to the bidder un-opened.

#### B. Terms and conditions: -

- 1. The work will be executed based on the specification as stated in the tender document.
- 2. The contactors who are interested to participate in the tender shall furnish Xerox copies Of their Registration Nos. / Trade License No., GST no. & pan card.
- 3. Earnest money will be forfeited if the contractors fail to commence the work as per letter of award.
- 4. The lowest bidder shall award the work order for execution of work.
- 5. The work should be started immediately after issue of work order and should be completed within one month from the date of issue of work order. Otherwise, penalty @ 1% of tender value will be charged to the Contractor per week of delay.
- 6. No extension of time will be allowed, if the above work is not completed within the stipulated time. ILS reserves the right to get it completed through any other source without sending any intimation to the contractor
- 7. After completion of the work the Contractor shall clean the site and remove debris from the site to outside of ILS.
- 8. The Contractor shall abide by the laws of the land for payments to labourers etc.
- 9. The work shall be executed based on the design approved by ILS.
- 10. The payment shall be made as per the actual measurement of the work done confirming to specification and design.
- 11. Income Tax, Sales Tax, etc. shall be deducted from the payment to be made to the Contractor as per the existing law.
