4. (A) Scope of Work:

The Director, Institute of Life Sciences, Bhubaneswar, invites Expression of Interest (EOI) from reputed and interested firms/manufacturers/companies for providing "SERVICE FOR SPATIAL TRANSCRIPTOMIC ANALYSIS OF HUMAN SAMPLES." Service provides should have experience providing similar services for spatial transcriptome to the clients (scientific research organizations, government academic institutes, and private organizations).

The broad scope of work will include the following:

- 1. Spatial Whole Transcriptome analysis of Human samples
- 2. Probing of the FFPE slide for whole transcriptome Atlas Genes (~22,000 genes)
- 3. From each slide containing 30-36 tissue slices of 3 mm diameter, 60 regions of interest (2 AOI/ROI and each ROIs of ~200 microns in size from each tissue slice), so in total ~ 120 AOI with segmentation per slide. There will be a total of 4 slides for the spatial transcriptome analysis.
- The service should include probing of provided TMA slides (~30/36 slices/slide), with RNA
 profiling reagents and suitable cellular morphological markers followed by library
 preparation from released barcodes.
- Deliverables include probing barcoding from areas of illumination followed by library preparation of individual AOIs with unique barcodes and pooled libraries from each slide.
- 6. Quality control for each step needs to be provided.
- Proper management & support in Next-generation sequencing of the pooled libraries followed by computational analysis for data interpretation is required.
- 8. Assuring timely completion of the service is mandatory.

Introduction:

The Institute of Life Sciences (ILS) was established in 1989 as an autonomous institute under the administrative control of the government of Odisha. In 2002, it was taken over by the Department of Biotechnology, Govt. of India. The Institute of Life Sciences has a broad vision of conducting high-quality multidisciplinary research in Life Sciences. The goal is the overall development and betterment of human health, longevity, agriculture, and the environment. The institution's stated mission is to uplift human society and generate skilled human resources for India's future. These are achieved by cutting-edge research using state-of-theart technologies in vector-borne diseases such as malaria and filaria, viral infections, cancer

biology, allergy and auto-immune disorders, genetic disorders, and agricultural productivity. Towards this, the institute has established the necessary infrastructure, including research facilities, genomics, and proteomics platforms, flow-cytometry, imaging facilities, animal house, green-house, plant tissue culture and zebrafish facilities, and high-performance computing facility, etc, with financial support from Dept. of Biotechnology, Govt. of India.

The Expression of Interest (EOI) received shall be evaluated based on experience and expertise to provide the service defined in the scope of work above. Only those vendors qualifying the same shall be considered for outsourcing services mentioned above.

The entire process of EOI shall consist of the following two stages:

Stage-I (EOI by the Vendors): Receipt of Expression of Interest (EOI) from specialized agencies meeting minimum eligibility criteria. A technical evaluation committee appointed by the Director, ILS, will evaluate the agencies based on the minimum eligibility criteria and terms & conditions specified in the EOI.

Stage-2 Evaluation of the financial part: The committee will verify the vendor's quoted price along with the agencies' terms and conditions. The committee might discuss online / offline with the Agency for clarification.

A Committee will comprehensively evaluate Service provider based on their credentials, quality control system, financial background, dealer/distributor network, and past performance/experience.
